



RULES

1. The name of the draw is "The Prize Bull 500 Club".
2. The purpose of the 'Prize Bull 500 Club' is to raise funds for Hereford United Supporters Society Limited (Hereford United Supporters Trust).
3. The first 'Prize Bull 500 Club' draw shall commence on Tuesday, 30th May 2017.
4. The subscription to the 'Prize Bull 500 Club' shall be £60 per year per number payable in advance by cheque or by standing order. Automated subscriptions can also be paid monthly.
5. Monthly subscriptions must be received before the date of the monthly draw to be entered in the draw. If received too late then they will be entered in the following monthly draw.
6. You must be 16 years old and above to participate in the 'Prize Bull 500 Club'.
7. Members may have, and are encouraged to have, more than one subscription.
8. Membership of the 'Prize Bull 500 Club' is not restricted to those associated with HUST or Hereford Football Club and you are encouraged to persuade family and friends to join.
9. The 'Prize Bull 500 Club' shall not be limited to 500 members. However, if we exceed 500 members, we will increase the weekly, monthly, and annual prizes accordingly.
10. A member is eligible for inclusion in the draws for any month so long as the subscription for that month has been paid.
11. Each member is allocated a permanent number in the draws at £5 per number. This number shall remain that members number while their subscription is up to date. This number will be allocated by the administrator. Members will be notified of their number.
12. There will be one prize draw each week which will take place on Tuesday nights. This will be conducted 'live' on Radio Hereford FC during half-time at home or away games, or at 8:30pm on other Tuesday evenings during the football season, and during the close season. There will be a HUST board representative and two independent witnesses present at each draw. A form recording the details of the draw will be signed by the HUST board representative and the witnesses.
13. In any matter requiring adjudication, the decision of the board of HUST shall be final.
14. The board of HUST shall have the power to amend, vary or revoke these rules at their discretion, and will notify the members of any changes on the HUST website.

15. The prizes awarded will depend on the number of members in the 'Prize Bull 500 Club' and will be at the discretion of the board of HUST.
16. Winners names will be displayed on the HUST website after each draw. The administrator will make all reasonable efforts to pay or post prizes to the winners within one week of the draw. Winners will be paid by cheque which will be sent to the last known address for the member. It is the responsibility of the members to notify the HUST 'Prize Bull 500 Club' of any changes to their address.
17. Numbers will be allocated in sequence when applications are received. No preference for a particular number will be granted.
18. To be entered in the annual draw, all participants must have made 6 months contributions. Any new member who has been a member for a shorter time may take part but will need to pay £5 per month for the number of months by which contributions are short.
19. There shall be a draw made each week using an automatic random number generator that the promoter deems appropriate. All participants are entitled to attend the draws and the weekly prize winning numbers will be drawn in the following order: 1st prize, 2nd prize and 3rd prize, followed by the Monthly and Annual Draws, which will be drawn in the same order, when due.
20. Any prize cheque not cashed within 6 months will be deemed a donation to HUST.
21. The Promoter will not pay a prize to any participant other than the purchaser of the winning number.
22. No participant will be included in the draw if the subscription has not been received. It is the responsibility of each participant to make sure they have paid their subscription. The promoter reserves the right to reallocate any number where payment has not been received.
23. Participants can cancel their entry at any time by giving one month's written notice to the promoter. Any decision to end the Prize Bull 500 Club will also be by one month's notice to all participants.
24. Under no circumstances can subscriptions be refunded.
25. The promoter will determine any dispute. An appeal may be made to the HUST board whose decision shall be final.
26. A list of all the members of the 'Prize Bull 500 Club' will be available to members on request.

28. The 'Prize Bull 500 Club' is operated in accordance with the Gambling Act 2005, and formally registered with Herefordshire Council.
29. These Rules were adopted by a meeting of the HUST board. The HUST promoter of the Lottery is Keith Hall.
